The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

Sections 7, 19, 28, 30-31

IN TOWNSHIP 32, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 1, 3-4, 6, 10, 12-13, 15-17, 20-22, 27-34

IN TOWNSHIP 32, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 25, 35-36

IN TOWNSHIP 33, RANGE 18, WEST OF THE 4th MERIDIAN:
Sections 5 and 6

IN TOWNSHIP 33, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 2, 6, 11-12

- 4) Coalbed methane and non associated gas production from the EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 20, WEST OF THE 4th MERIDIAN:
Section 12

- 5) Coalbed methane production from the HORSESHOE CANYON FM CBM UHSC, HORSESHOE CANYON FM CBM WAYN, HORSESHOE CANYON FM CBM DBSL, and HORSESHOE CANYON FM CBM RS may be taken

without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 33, RANGE 20, WEST OF THE 4th MERIDIAN:
Section 1

- 6) Coalbed methane production from the HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 31, RANGE 19, WEST OF THE 4th MERIDIAN:
Section 28

IN TOWNSHIP 32, RANGE 18, WEST OF THE 4th MERIDIAN:
Sections 18 and 29

IN TOWNSHIP 32, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 23-25, 35

IN TOWNSHIP 33, RANGE 18, WEST OF THE 4th MERIDIAN:
Section 18

IN TOWNSHIP 33, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 1, 4, 10, 21, 31

- 7) Non associated gas production from the BELLY RIVER GRP and BASAL BELLY RIVER SD may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 32, RANGE 18, WEST OF THE 4th MERIDIAN:
Sections 7, 18-19, 28-31

IN TOWNSHIP 32, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 1-4, 10-15, 17, 19-22, 25-36

IN TOWNSHIP 32, RANGE 20, WEST OF THE 4th MERIDIAN:
Sections 24-25, 35-36

IN TOWNSHIP 33, RANGE 18, WEST OF THE 4th MERIDIAN:
Sections 5, 18-19

IN TOWNSHIP 33, RANGE 19, WEST OF THE 4th MERIDIAN:
Sections 1-2, 5-6, 10-13, 17

IN TOWNSHIP 33, RANGE 20, WEST OF THE 4th MERIDIAN:
Section 2
