The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

IN TOWNSHIP 31, RANGE 29, WEST OF THE 4th MERIDIAN:
Sections 13 and 35

IN TOWNSHIP 32, RANGE 28, WEST OF THE 4th MERIDIAN:
Sections 3, 5, 7

Section 6
