The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

- 1) The following table shows the specified pools and wells in the **PENHOLD Field** wherein production may be commingled in the wellbore:

a) PENHOLD EDMONTON A, PENHOLD EDMONTON C, and PENHOLD LOWER EDMONTON C	All
b) PENHOLD VIKING A, PENHOLD VIKING B, PENHOLD VIKING E, PENHOLD VIKING I, PENHOLD VIKING J, PENHOLD VIKING L, PENHOLD LOWER MANNVILLE C, PENHOLD LOWER MANNVILLE N, PENHOLD LOWER MANNVILLE T, PENHOLD LOWER MANNVILLE U, and PENHOLD LOWER MANNVILLE V	All
c) PENHOLD LOWER MANNVILLE D, PENHOLD LOWER MANNVILLE E, PENHOLD LOWER MANNVILLE F, PENHOLD LOWER MANNVILLE G, and PENHOLD LOWER MANNVILLE H	All

- 2) Non associated gas production from EDMONTON GRP and LOWER EDMONTON may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 36, RANGE 28, WEST OF THE 4th MERIDIAN:  
Sections 19, 22, 31

IN TOWNSHIP 37, RANGE 28, WEST OF THE 4th MERIDIAN:  
Sections 2, 9-12

- 3) <sup>1</sup> Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 36, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 2, 4, 10-14, 16, 22-24, 35-36

IN TOWNSHIP 37, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 2-3, 12

- 4) Coalbed methane and non associated gas production from HORSESHOE CANYON FM and BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 36, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 2, 4, 10-12, 14, 16, 22, 24, 35

IN TOWNSHIP 37, RANGE 27, WEST OF THE 4th MERIDIAN:  
Sections 2-3, 12
