The Energy Resources Conservation Board (ERCB) pursuant to the *Oil and Gas Conservation Act*, chapter O-6 of the Revised Statutes of Alberta, 2000, orders as follows:

- 1) The following table shows the specified pools and wells in the **LACOMBE Field** wherein production may be commingled in the wellbore:

- 3) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, BELLY RIVER GRP, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 41, RANGE 26, WEST OF THE 4th MERIDIAN:
Section 6

- 4) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 41, RANGE 26, WEST OF THE 4th MERIDIAN:
Section 35

- 5) Coalbed methane and non associated gas production from EDMONTON GRP, HORSESHOE CANYON FM, LETHBRIDGE, RIBSTONE CREEK MBR, VICTORIA MBR, and BROSSEAU MBR may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 39, RANGE 25, WEST OF THE 4th MERIDIAN:
Sections 20, 25-26, 30-31, 35

IN TOWNSHIP 40, RANGE 25, WEST OF THE 4th MERIDIAN:
Section 4

IN TOWNSHIP 40, RANGE 26, WEST OF THE 4th MERIDIAN:
Sections 4 and 5

- 6) Associated gas and non associated gas production from EDMONTON GRP and BELLY RIVER GRP may be taken

without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 39, RANGE 25, WEST OF THE 4th MERIDIAN:
Sections 16, 22, 28-29, 34, 36

- 7) Coalbed methane and non associated gas production from HORSESHOE CANYON FM and BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 39, RANGE 25, WEST OF THE 4th MERIDIAN:
Sections 20 and 26

IN TOWNSHIP 40, RANGE 25, WEST OF THE 4th MERIDIAN:
Section 4

IN TOWNSHIP 40, RANGE 26, WEST OF THE 4th MERIDIAN:
Section 4

- 8) Coalbed methane production from HORSESHOE CANYON FM and BELLY RIVER GRP may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 40, RANGE 25, WEST OF THE 4th MERIDIAN:
Section 6

- 9) Coalbed methane and non associated gas production from HORSESHOE CANYON FM and LETHBRIDGE may be taken without segregation in the wellbore from wells in the following areas:

IN TOWNSHIP 40, RANGE 25, WEST OF THE 4th MERIDIAN:
Section 6

IN TOWNSHIP 41, RANGE 26, WEST OF THE 4th MERIDIAN:
Sections 16, 18, 20, 22, 24, 28-29, 32, 36
