Dear Ms. Somers:

You are receiving this letter because you filed a statement of concern about Applications No. A10026515, A10026518, A10026523, A10026527, A10027815, OSE160002, OSE160003, OSE160004 and OSE160005.

The Alberta Energy Regulator (AER) has reviewed your statement of concern, along with the application, the applicable requirements, and other submissions or information about the application and has decided that a hearing is not required under an enactment or otherwise necessary to consider the concerns outlined in your statement of concern.

In its review of your concerns, the AER considered the following:

- ACFN has not demonstrated that it may be directly and adversely affected by the licence extension request.
- These applications only seek to extend the length of existing approvals. ACFN has not provided information to demonstrate this change to the timeline for the subject project may impact ACFN.
- The concerns raised by you have been adequately dealt with or addressed through the hearing on Teck's 2013 winter drilling program that resulted in

decision 2013 ABAER 017. In that decision the AER concluded that the “nature of activities and the mitigation proposed by Teck are such that the activities will not result in significant adverse effects on the environment, the RLBH [Ronald Lake bison herd], or Aboriginal traditional land use and rights”, and the “effects...will be localized, temporary and of short duration” (para 112).

- Concerns about impacts from the Frontier project are to be considered in the context of that proceeding.
